(iii) Fairness Opinion Report given by M/s D & A Financial Services (P) Ltd, SEBI registered Merchant Banker, on the share entitlement ratio recommended by M/s S. S. Kothari Mehta & Co., Chartered Accountants, New Delhi ("Fairness Opinion Report").

The Board of Directors of TTPL has also approved the Scheme of Arrangement, Valuation Report and the Fairness Opinion Report in its meeting held on 13<sup>th</sup> November, 2015.
